

# Win With Biozet

## "SuperChem May 2017" Promotion

1. These terms and conditions, including information on how to enter, and a description of the prize that may be won in the Promotion, apply to the Win With Biozet – SuperChem May 2017 competition. These terms and conditions can be viewed by clicking the “Terms & Conditions” button on the WinWithBiozet.com website ("Competition Details").
2. Participation in the Win With Biozet competitions constitutes acceptance of these Terms and Conditions and any Competition Details.
3. Entry is only open to Australian residents over the age of 18 who purchase the specified BioZet product from participating pharmacies during the promotional period. Employees (and their immediate families) of the Promoter, participating outlets and their agencies associated with this promotion are not eligible to enter. ("Eligible Entrant")
4. This Promotion (the "Promotion") starts 07:00am AEDT 1st May 2017 and ends at 11:59pm AEST 31<sup>st</sup> May 2017.
5. To enter, an Eligible Entrant must purchase a 1kg or 1 Litre BioZet product from a SuperChem participating participating pharmacy (“Qualifying Purchase”) and register their purchase online at WinWithBiozet.com. Registration requires the submission of the Entrant’s name, address, phone number, email address and proof of purchase.
6. Multiple entries permitted. Eligible Entrants will receive one (1) entry per qualifying purchase.
